## **Personnel & Planning Committee**

Report: Committee Meeting – Friday, September 22, 2017, 10 AM, MHLS

- 2. Meeting Called to Order by Mr. Bickford
- 3. MHLS Personnel Policies
  - A. The Committee discussed how best for MHLS personnel policies to be reviewed and revised if needed.
  - B. The Committee agreed, MHLS would contract with a human resources specialist(s) to:
    - 1) Review the MHLS Personnel Manual's Table of Contents and identify policies that fall under specific legal requirements/Federal or NY State law/regulatory oversight;
    - 2) Review all policies that fall under specific legal requirements/Federal or NY State law/regulatory oversight and recommend revision language as needed.
- 4. MHLS Plan of Service 2017-2021
  - A. The Committee agreed to review a revised DRAFT of the Progress Report on the MHLS Plan of Service based on comments and any changes resulting from review and recommendations by the Directors Association.
- 5. MHLS & CSEA Agreement
  - A. The Committee discussed the collective bargaining agreement with Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO regarding a 2017 comparative salary study between MHLS and selected New York State Library Systems. Survey findings would inform limited negotiations between MHLS and CSEA regarding salaries for 2018.
  - B. The Committee reviewed the findings of the 2017 salary survey and a report on MHLS part time hourly wages compared to the NY state mandated minimum wage.
  - C. The Committee agreed on a recommended amount for 2018 salary adjustments for full time and part time staff. The recommended amount will be used to inform discussions with CSEA regarding 2018 MHLS salaries.
- 6. The Committee agreed to meet in the October or November. Agenda items will include a review of the revised DRAFT Report on the MHLS Plan of Service

<u>PERSONNEL AND PLANNING COMMITTEE</u> - Works to prepare and review the System's formal long-range Plan of Service. Reviews and makes recommendations regarding the executive director's job description and evaluation procedure, salaries, benefits, and other matters pertaining to staff and employment conditions.
