Executive Director's Report to MHLS Board – January 2018

1. 2017-2021 PLAN OF SERVICE

- A. MHLS has COMPLETED a comprehensive strategic planning process resulting in:
 - (1) A cost and benefit analysis of all MHLS services
 - (2) The prioritization of all MHLS services by MHLS stakeholders
 - (3) The approval by the MHLS Board and the NY State Library of the MHLS Plan of Service 2017-2021
 - (4) The development, approval, and implementation of detailed Action Plans to deliver MHLS services as identified in the MHLS Plan of Service
 - (5) The allocation of MHLS resources based on the service priorities selected by stakeholders
 - (6) An integrated process for collecting service data and reporting on the MHLS Plan of Service to MHLS stakeholders and the NY State Library
- B. A special thank you to Merribeth Advocate for her essential contributions to all aspects of the planning process and to Linda Vittone for her exceptional accounting and calculations.

2. PUBLIC LIBRARY TRENDS

- A. Key findings as reported in the article 2017 Public Library Data Service Report:
 - (1) Library programs per capita have grown (6.3%)
 - (2) Library circulation per capita has decreased (-3.0%)
 - (3) Electronic circulation is growing steadily at a rate of 11.7%, but not sufficiently to offset the decline in physical materials circulation
 - (4) Consortial sharing relationships for electronic materials significantly increased Holdings for libraries serving populations of less than 100,000

3. GOVERNOR'S EXECUTIVE BUDGET PROPOSAL

- A. Proposed State Library Aid: \$91.6M (3% cut from 2017)
- B. Proposed Library Construction Aid: \$14M (42% cut from 2017, which would mean a \$378,392 decrease in available construction aid funds for the MHLS region)
- C. Next the NYS Assembly and Senate will create their budget proposals, as has been the pattern over the past few years this is an opportunity for the library community to influence where the dollar amounts will fall in the final budget which is legally required to be approved by April 1.
