- 2. Meeting called to order & meeting agenda adopted Mr. Wilson
 - A. Motion to approve meeting agenda made by Mr. Ramage and seconded by Ms. Brill. The motion carried.
- 3. Notice of Mr. Sloan's recusal from the Search Committee process Mr. Wilson
 - A. Mr. Wilson noted for the record Mr. Sloan's notice to the Search Committee via email on Friday, February 16 to recuse himself from any future activities regarding the review and selection of the search firm, as one of the potential firms has contacted Mr. Sloan for a preliminary interview regarding a client search. Mr. Sloan will continue to provide support for all other aspects of the search as requested by the Committee, and Linda will continue as staff liaison. No further discussion ensued.
- 4. Review, discussion and subsequent action steps regarding search-firm proposals submitted by February 16, 2018 deadline in response to RFP outreach
 - A. Committee members discussed their general impressions regarding the two executive search firms that submitted proposals for their services out of the five RFPs sent to interested firms, namely:
 - 1) John Keister & Associates | Vernon Hills, IL
 - 2) Bradbury Miller Associates | Kansas City, MO
 - B. Mr. Wilson volunteered to interview both firms and requested a second volunteer. Mr. Swierat volunteered and will contact the firms for best dates / times. When confirmed, the appointments will be sent to all Search Committee members. Mr. Wilson invited the members to join in the call if desired.
- 5. Response from Ms. Ellen Bach, Esq. regarding inquiry on Open Meetings Law Mr. Sloan
 - A. Based on a request from the Committee, Mr. Sloan wrote to Ellen Bach, Whiteman Osterman & Hanna LLP, with the following questions:
 - Does the MHLS Board Executive Committee/Search Committee fall under the NY Open Meetings Law? OML advisory opinions appear to state that a committee or

- subcommittee consisting solely of members of a governing body is itself a public body and would fall under OML. If no, that ends our questions. If yes, see questions 2-5.
- 2) Does the requirement of the MHLS Board Executive Committee/Search Committee to act under the OML change if the Search Committee is composed of both MHLS Board members and persons who are not MHLS Board members?
- 3) Does the requirement of the MHLS Board Executive Committee/Search Committee to act under the OML change if the Search Committee is only advisory on the hiring of the Executive Director, as in making a recommendation to the Board to hire and the Board, in an open meeting, officially hires the new Executive Directors?
- 4) If the MHLS Board Executive Committee, acting as the MHLS Search Committee, does fall under OML, must the names of persons who have applied for the position and are selected to be interviewed be posted in Committee meeting documents?
- 5) If the MHLS Board Executive Committee, acting as the MHLS Search Committee, does fall under OML, may interviews of candidates for the position be conducted under Executive Session since "employment history of a particular person" and "matters leading to the appointment, employment... of a particular person" are being discussed?
- B. Mr. Sloan informed the committee that Ms. Bach advised that the Committee on Open Government would find the Executive Committee / Search Committee is subject to the Open Meetings Law. However, the courts have not been so clear on this issue. The Search Committee can appropriately go into executive session to discuss any matter leading to the appointment of a particular person and with regard to discussion of particular candidates. The actual interview of candidates can be held in executive session, since the interviews will involve matters leading to the employment of a particular person.
- C. Mr. Sloan advised that the meetings be placed as public notices on the calendar and that the Committee then proceed through the agendas that identify when the meeting goes into executive session. The Committee may wish include an executive sessions on future agendas regarding discussion of hiring a search firm and the interview of candidates.
- D. Mr. Sloan will look into how to ascertain that attendees using GoToMeeting sign off during executive sessions that only Search Committee members may attend.
- E. Mr. Sloan informed the committee that Ms. Bach had not yet answered the question regarding posting names of persons selected for interviews.
