Report: Committee Meeting – Monday, June 25, 2018, 10 AM, MHLS

- 2. Mr. Swierat called the meeting to order and the agenda was adopted.
- 3. MHLS Personnel Policies Handbook
 - A. The Committee reviewed the background on the revision of the MHLS Personnel Policies Handbook, which included the Committee's agreement in 2017 that MHLS should have a professional review of all personnel policies and develop a recommended revised/updated Handbook.
 - B. MHLS Administrative Team members reported: (1) Marshall & Sterling services were obtained to review the 2008 MHLS Personnel Policies Handbook and draft a revised 2018 Handbook; (2) several drafts of the revised Handbook were reviewed by the MHLS Administrative Team and MHLS supervisors; and (3) a draft of the Handbook was provided to all MHLS staff for review and comment.
 - C. The Committee agreed the draft Handbook should be provided to the full MHLS Board for review and comments at the July 11 meeting of the Board.
 - D. The Committee requested the sections in the Handbook citing the MHLS Board be highlighted and separately listed.
 - E. The Committee agreed to meet again in late August or early September for a final review of the Handbook and to decide on a recommendation to the Board regarding adoption of the Handbook at the September 12 meeting of the Board.
- 4. MHLS Plan of Service 2017-2021
 - A. The Committee reviewed the background on the development, adoption, and implementation of the MHLS Plan of Service.
 - B. The Committee agreed the form and format of the Report on MHLS Action Plan, which had been reviewed in draft by the MHLS Board on May 9 and by the MHLS Directors Association on June 6, provided the information needed for stakeholders to track and assess the implementation of the Plan of Service.
 - C. The Committee reviewed a proposed process for revisions to the Plan of Service. ACTION: The Personnel and Planning Committee recommend the MHLS Board approve the proposed process for revisions to the MHLS Plan of Service.
