Executive Director's Report to the MHLS Board | December 2023

1. State Update

- a. The 414 Municipal Ballot Petition Signature Reduction bill has been signed into law. In 2024 member libraries will be able to get on the General Election ballot with 25 signatures. We will be working with the State Library to update both the <u>Public Library District Toolkit</u> and <u>Inch by</u> Inch "how-to" document to reflect this advancement.
- b. FY 2024 Budget Advocacy:
 - i. Please reach out to Governor Hochul using the New York Library Association's Call to Action Campaign to express your opinion on the importance of an increase in state aid for System operations and library. Construction.
 - Now is also a good time to reach out to your local state Senator and Assemblyperson to ask for their help in advocating for an increase in System operating aid. Many newer legislators may not understand how public library systems in New York State work to benefit local libraries and their constituents.
 - ii. NYLA Library Advocacy Day in Albany is scheduled for Wednesday, February 7, 2024. We are partnering with the Ramapo-Catskill Library System to have buses transport advocates to Albany. We will have a stop in Putnam County for the first time in addition to the usual stops along the NYS Thruway. Please register today through the <u>MHLS</u> <u>Calendar</u>.

- b. We have received the first draft of a new Personnel Handbook from Visions Human Resource Services, LLC to ensure our policies follow state and federal law. We are comparing this to our current policy manual to ensure alignment with the CSEA contract. We will report our findings to the MHLS Personnel & Planning Committee.
- c. For National Kindness Day (November 13th) MHLS staff collected donations for the Dutchess County SPCA
- d. In the first quarter of 2024, the Equity, Diversity, Inclusion, and Justice Discussion Series will be convened for new/newer staff.

3. Facility

- a. Roof & Solar Project
 - i. The bid was awarded to United Solar for both the roof and solar installation project.
 - ii. The roof project is completed. The solar project will start in mid-December.
- b. The railings on the front of the office building have been replaced.

- c. The Pollinator Garden installation has been completed.
- d. No Trespass Order filed with the City of Poughkeepsie Police Department. This has, thus far, proven to be effective in deterring folks from camping out on the property overnight.
- e. Mandatory Active Shooter Training for staff was held on September 26th. This program was provided free of charge thanks to the City of Poughkeepsie Police Department.
- f. Clean Up/Clean Out Day, an annual staff event, was held on October 31st.

4. Memo of Understanding Development Update:

a. The MHLS Directors Association has approved a draft for your consideration. This document is the result of over a years' worth of work between the MHLS staff, board and Directors Association. This is the fifth draft, all counties' director's groups had multiple rounds of feedback on the document. The goal is to retain the "Good Neighbor" mentality our libraries currently exhibit and ensure what is working about the MHLS-Member Library relationship is preserved. This is an action item under the MHLS Executive Committee's section of the agenda.

5. Path to System Membership Joint Committee

a. A joint committee made up of members of the MHLS Executive Committee and MHLS System Services Advisory Committee were convened to discuss and propose steps in the path for a library that request membership in the Mid-Hudson Library System. The committee's report can be found as an action item under the MHLS Executive Committee's section of the agenda.

6. Technology Operations

- <u>Discover.MidHudsonLibraries.org</u> will be widely available to the public starting Wednesday, December 6th, 2023. Training and resource development by MHLS staff are archived here: <u>https://kb.midhudson.org/vega/</u> This includes a "Launch Kit" to help member libraries advertise the new catalog to their communities.
 - i. Help Guides in the new catalog have been customized for MHLS at no additional cost thanks to the leadership of Assistant Director and Technology Operations Manger Laurie Shedrick.
- b. At the DA's request we have implemented a new filed in Sierra for "Preferred Name." This enables a patron to use a preferred name over their legal name in the patron field.
