Executive Director's Report to the MHLS Board | July 2023

1. State Update

- a. Our 414 Municipal Ballot Petition Signature Reduction bill passed in both houses and has been delivered to the Governor for her consideration. The New York Library Association has provided, upon their request, a letter of support urging her to sign this bill into law. Thank you to all who helped us get this bill through the legislature this session, once signed into law this will ease the way for more than half of our libraries to access the ballot on Election Day for funding referendums.
- b. The State Librarian has announced they will sunset the NOVELny program on June 30, 2024. There are ongoing discussions regarding a statewide cost share model to retain some of the resources the library community has come to depend on in this collection.

2. <u>Personnel Updates</u>

- a. We have hired Rebecca Hagen as our new Interlibrary Loan (ILL) & Cataloging Specialist. Rebecca comes to us from the Millbrook Library.
- b. In keeping with our goal to pay all staff a living wage, as well as to be competitive in the job market, I am recommending a salary adjustment for two of the part-time positions on the Delivery Team. The recommended levels in the Personnel Action document would be our last step to ensure all staff, full and part-time, are paid a living wage.
- c. We are in progress on the search for a new Finance Manager & Personnel Officer.
- d. Farah Faizi has decided not to return to work after her maternity leave ends. A search is underway to fill this position.
- e. Kerri Carpenter, our Cataloging Specialist, has let us know she will be moving out-of-state and leaving her employment with MHLS in mid-July. A search is underway to fill this position.

3. Delivery Services

a. We reinstated the analysis of delivery volume to right-size our delivery contract. This was the first time this activity was undertaken since the beginning of the pandemic and our overhaul of the delivery schedule in light of the major disruptions to delivery volume due to the impact of the pandemic on library usage. The most recent evaluation resulted in a reduction of 14 stops per week. Our methodology was reviewed by the MHLS System Services Advisory Committee, and each impacted library was notified in advance. The new schedule went into effect the same day our renewed contract started with Valley Courier on July 1, 2023.

4. Facility

- a. Roof & Solar Project
 - i. Requests for Proposals (RFP) for our roof replacement and solar project were published the week of July 3rd.

- ii. Enclosed in this month's board packet is the assurances page of the application for State Aid for Library Construction funding for this project. The board will need to vote on this and our board president will need to sign it for inclusion in our application package.
- iii. We were notified that we did not receive the EBSCO Solar Grant.
- b. The Pollinator Garden project will move forward pending the availability of our landscape contractor. Thank you to all who personally donated to underwrite this project.
- c. All air handler filters have been replaced due to our routine replacement schedule, this also allowed us to assess the condition of the filters after the recent bouts of smoke from the Canadian wildfires.
- d. The Dutchess County Board of Elections once again used the MHLS Auditorium to host the primary election in June.
- 5. <u>Annual Report to the State</u>: The NYS Division of Library Development (DLD) has notified us that our Annual Report for Library Systems 2022 has been approved. This enables us to receive our state aid this year in a timely manner. Thank you to Laura Crisci, MHLS Library Sustainability Coordinator or organizing our submission this year and addressing questions that DLD had about our report.
- 6. <u>Memo of Understanding Development Update</u>: The fourth draft will be presented to the System Services Advisory Committee this summer.
- 7. Partnership with the Adirondack (ADK) Mountain Club: Thanks to a third year of partnership with the ADK Mountain Club twelve (12) member libraries have received program grants averaging \$500 each. This program was built upon the belief that young people who learn to love things in nature will want to protect nature when they are adults when they can make a difference in their work, community involvement and recreation. They will support ADK's mission, and most importantly, they will want to save the environment.
 - a. D.R. Evarts Library, Athens: Development of loanable nature backpacks designed to increase patron's understanding and appreciation of natural resources and each person's role in conserving.
 - b. Beekman Library: Funding of a monthly after school Nature Club.
 - c. Julia L Butterfield Memorial Library, Cold Spring: Creation of a nature and sustainability oriented Little Free Library on the Hudson River waterfront.
 - d. Kent Public Library: Nature backpacks which include a guidebook to the backpack's ecological theme and tools.
 - e. Kinderhook Memorial Library: A three-part multi-season program called "Native Plants and Pollinators in Columbia County" in conjunction with the Columbia Land Conservancy.
 - f. Millbrook Library: Two new program series for children and teens: Family Nature Walks & Teen Eco-Crafts.
 - g. Reed Memorial Library: Creation of a StoryWalk themed "Treating Nature with Kindness" on the Putnam County Bike/Trailway.

- h. Roeliff Jansen Community Library, serving Ancram, Copake, and Hillsdale: Expand its outdoor program along a trail to the Roe Jan Kill.
- i. Staatsburg Library: Collaboration with the Pollinator Patrol Club for nature exploration through a series of 12 guided hikes, and an introduction to citizen science through a Monarch butterfly larva monitoring program.
- j. Tivoli Free Library: Support ecology based, reusable, STEM and Arts Kits for families and children aged 1-14.
- k. Grinnell Public Library District, Wappingers Falls: Outdoor Explorer Backpacks which contain different nature-themed books, observation tools, and other exploration items.
- I. Woodstock Library: Guided hikes and hiking packs as a part of the library's "Woodstock Gets Wild: Outdoor Adventures Beyond the Library Shelves" program.

8. IMLS Visit

- a. At the request of the New York State Division of Library Development we are hosting a day-long visit with staff from the Institute of Museum and Library Services (IMLS). The visitors, who oversee the five-year plan for our state library, are interested to learn more about how the American Rescue Plan Act (ARPA) funds have benefitted libraries and what results have been achieved for our communities. Our plan is to tour the following libraries who have deployed ARPA funds in their communities:
 - Kingston Library: Participants in the <u>Digital Navigators of the Hudson Valley</u> Program & a Library and Museum Partnerships project: <u>Kingston Immigrant Oral History Project</u> (Kingston Public Library / Reher Center for Immigrant Culture and History)
 - **ii.** Hudson Area Library: Participated in both the <u>Digital Navigators Program</u> & benefitted from equipment purchased and installed thanks to our Beyond the Library WiFi program
 - iii. MountainTop Library (Tannersville): Participated in both the <u>Digital Navigators Program</u> & benefitted from equipment purchased and installed thanks to our Beyond the Library WiFi program
- 9. Summer Reading Program Launched Across the Hudson Valley



- a. This year's Summer Reading Program theme is "All Together Now."
- **b.** Member libraries are hosting kick-off parties to help families connect with this educational and fun program that is designed to:

- i. Advance literacy and maintain reading skill levels by engaging children and teens in reading and enrichment activities during the summer months.
- ii. Foster a love of reading and using the library through public library programs and services.
- iii. Increase successful reading experiences through librarian-supported, self-selected, voluntary reading.
- iv. Involve parents, caregivers, and all family members in the library summer reading experience.
- v. Improve children's access to library materials and activities, which will encourage them to become lifelong library users.
- vi. Increase the number of children and teens participating in public library summer reading programs.
- vii. Increase collaboration between schools and school libraries and public libraires, to promote, facilitate and increase Summer Reading participation.
- c. New York State has released the remaining funds from the "Love Your Library" Fund, which benefits from fees associated with the custom NYS license plate to advertise support of libraries. These funds will be distributed to each county for help in the support and promotion of the summer reading program.
