# **Executive Director's Report to the MHLS Board | July 2025**

### 1. State Updates:

- a. The State Library has received their federal funding via the Grants to States Program, administered by the Institute of Museum and Library Services (IMLS). This will fully fund the NYS Division of Library Development through October of 2026 and should mean that state aid flows normally from the Division of Budget to MHLS barring any catastrophic events that negatively impact the state's budget.
- b. The Governor has been given special authority to make **mid-year cuts** this fiscal year should the outcome of federal budget deliberations have a deeper, negative impact on New York State than is currently calculated.

# c. Special Legislative Grants

- Senator Michelle Hinchey has notified us that she has secured a \$30,000 special legislative grant that will be awarded to MHLS to support the libraries in her district via several of our projects, including The Library of Local, The Tempestry Project, and the Digital Navigators of the Hudson Valley.
- Assemblymember Didi Barrett has notified us that she has secured a \$100,000 special legislative grant that will be awarded to MHLS and split evenly as cash grants among the libraries of her district.
- d. We have been authorized to submit our application for the Community Resiliency, Economic Stability and Technology (CREST) grant through the Dormitory Authority of NYS **to help underwrite MHLS capital projects**. This is thanks to the work of Assemblymember Jonathan G. Jacobson.

# 2. Federal Updates:

- a. Given the pace of events, a report on the status of the **Institute of Museum and Library Services (IMLS)** will be provided at the meeting to ensure you have the most up-to-date information.
- b. Our application for the Energy Credit through the IRS was denied without explanation. We are pursuing an appeal, however, given the passage of the recent budget reconciliation bill which terminates these credits, our effort may be for nothing. As a reminder, this credit, as allowed for by the Inflation Reduction Act, would reimburse part of the cost of the rooftop solar project. These credits are threatened by the current budget bill being debated in Washington D.C.

c. The Supreme Court upheld the fee that is added to phone bills to fund the **E-Rate program** which subsidizes phone and internet services in schools and libraries.

### 3. <u>Personnel:</u>

- a. Please join me in welcoming Elinor Levy as the new Administrative Assistant.
- b. **Thomas Finnigan, MHLS Delivery Operations Manager, has announced his plans to retire**. His last day will be September 1, 2025.
  - As per our Employee Benefit Accrued Liability Reserve Policy, I am notifying you that we will be transferring \$13,452.95 from that reserve fund to pay out Tom's unused vacation time.
- c. We will be promoting Chris Herron, currently our Facilities Manager & Assistant Delivery Operations Manager, to a new role, that of Operations Manager. Chris will oversee both Delivery Operations and managing our buildings and grounds.
- d. We will be promoting Dave Haspel, currently our Delivery Operations and Facilities Associate, to the new role, that of Assistant Operations Manager. Dave will assist Chris to oversee both Delivery Operations and managing our buildings and grounds.
- e. Kerstin Cruger, MHLS Outreach and Equity, Diversity, and Inclusion (EDI) Specialist has been elected incoming President of the New York Library Association!
- 4. The MHLS Directors Association has approved a 9.5% increase to the Members Assessment for 2026. This increase impacted members differently from community to community based on the formula which is weighted based on three-year averages of circulation and holds. This will result in an additional \$60,856 in revenue for MHLS. We are greatly appreciative of the DA for the foresight to more deeply invest in the Members Assessment line of revenue for MHLS next year in light of the combination of stagnant state aid, rising inflation, and the concerns surrounding the federal budget's impact on state finances.

### 5. Facilities

- a. The request for proposal (RFP) for the **third floor HVAC system** went out on schedule. Responses are due by July 25. Reminder: We will apply for State Aid for Library Construction to help underwrite the cost of this project.
- **b.** We have signed a letter of intent to move to the next stage of development and research for **Central Hudson's Community Geothermal Project**.
- c. The Poughkeepsie Public Library District has notified us of their plans to separate their internet connection from ours. We currently share a broadband connection that runs through

our network equipment on the third floor. They will have new fiber run to their own building on Market Street. The timeline for this work is unclear.

**6.** <u>Delivery Operations</u>: The request for proposal (RFP) for delivery services went out on schedule. Responses are due by July 30.

# 7. <u>Technology Operations:</u>

- a. Mobile App updates:
  - The mobile app has been downloaded by 1,700 patrons so far.
  - We are pilot testing ad hoc push notifications.
- b. We are offering an **Introduction to E-Rate webinar** now that the program is confirmed to continue by the Supreme Court. We also have an E-Rate series on MHLS Training on Demand for step-by-step instructions to help libraries access these funds.
- c. Our member libraries have voted to **remove A.I.-generated content in the Hoopla collection** from the MHLS shared catalog.
- d. I recently attended the **Library Futures eBook Summit** at The Ferguson Library in Stamford, CT. This summit discussed the current attempts to work with publishers to bring the cost of licensing e-content under control, including legislation in various states, including Connecticut. While at the summit, the Connecticut bill was being debated on the floor of their legislature and ultimately passed. It will bar state funds from being used to purchase ebooks under the current licensing framework but will not kick in until another state or enough states with at least 7 million in population follow suit. As a result of my participation at this summit I am now part of working group in New York that is exploring content negotiation strategies, ideal contract language, and fine-tuning our own ebook legislation.

### 8. <u>Library Sustainability</u>


### a. Advocacy Push:

d. We once again hosted the **Mexican Consulate** in April and June in the MHLS Auditorium in partnership with the Poughkeepsie Public Library District. In April, the Mexican Consulate was able to assist **923** people with passports, renewals, dual citizenship and birth certificates, many of them for children. The Consulate offered additional financial workshops, a health services mobile unit and a large food pantry donated by the Hispanic Federation


