# Calling All Library Advocates: Five Easy Things You Can Do Now

A message from MHLS Executive Director, Rebekkah Smith Aldrich

The first five months of 2025 have been a lesson in the power of library advocacy. We were confronted with not only our traditional state budget advocacy season, but the chaos created at the



federal level by an Executive Order that called for the dismantling of the Institute of Museum and Library Services (IMLS), the granting agency that funds the New York State Division of Library Development (DLD).

I harbored concerns over overwhelming our advocates, people like you who volunteer to serve their local community through their local library. But every time we put out a call to action? *You answered*. You showed

up. You spoke up. You stood up for your neighbors, our libraries, our library system, and the core values we share.

#### The results?

- A state budget outcome that, despite all odds, contained a modest increase for library operating aid and a restoration of \$10 million to the State Aid for Library Construction.
- A lawsuit from the New York Attorney General that helped to halt the dismantling of IMLS (for now.)
- Dear Appropriator letters from Senator Gillibrand and Congressmen Riley and Ryan, a first step toward the renewal of the legislation that will retain the IMLS and Grants to States program for the next several years.

Your voice makes a difference. That has been proven.

The challenge now lies in the fact that the chaos continues, and we will need to stay vigilant. On the horizon we are watching three key things:

- 1. The potential for mid-year cuts to the budget of the Mid-Hudson Library System should the federal reconciliation budget process prove too punishing for our state, this could happen in the fall;
- 2. The Supreme Court ruling on the E-Rate program which is expected in July; and
- 3. The renewal of the federal Library Services & Technology Act (LSTA), which would also happen in the fall, which is how we protect IMLS and DLD funding.

Below, in the "Ask Rebekkah Anything" section, you will find more detailed information that helps give you context for these three things and should help you make the connections to the future calls to action that seem inevitable at this time.

In the meantime, here are five things you can do now to stay ready:

- 1. Take time to check out your own local library's Summer Reading Program and visit other member libraries during the <u>2025 MHLS Road Trip</u> to observe the amazing work library staff do every day to help the children and folks of all ages in our communities enjoy reading and learning. Nothing will keep you fueled more than the reminder of why we all do what we do.
- 2. **Sign up for** Library Advocate e-mail alerts from the New York Library Association.
- 3. Work on your storytelling abilities. Nothing sticks with a legislator more than a story about how your library or our system makes a difference in the lives of others. Check out the

<u>Advocacy Story Template</u> from the American Library Association to think through the narratives you want to present.

- 4. **Ensure your library's membership in NYLA** and <u>ALA</u> are up-to-date. Membership dues are what makes the advocacy and lobbying work each organization engages in on our behalf possible.
- 5. **Take care of yourself.** The world can feel overwhelming at times. Be sure to take time to do what sustains you, to be with folks who make you happy, and enjoy the beautiful Hudson Valley in the way that makes the most sense to you.

Thank you for all you do for our libraries and the Mid-Hudson Library System. *You* are making a difference.



## **Ask Rebekkah Anything:**

A regular feature in the MHLS Bulletin and now the MHLS Trustee eNewsletter! MHLS Executive Director, Rebekkah Smith Aldrich, has worked with area library boards for over 25 years. Co-author of the *Handbook for Library Trustees for New York State*, Rebekkah has a lot of experience with answering questions from more than 6,000 library trustees statewide. Here are answers to some recent questions that came in from trustees:

**Q**: What is the NYS Division of Library Development (DLD) and how would its defunding impact my library?



**A:** DLD is one of two divisions within the New York State Library. DLD administers state-level funding for public and

association libraries and public library systems as well as the Reference and Research Library Resource Systems (3Rs) and school library systems. The federal Grants to States program, administered by the Institute of Museum and Library Services (IMLS) provides \$8.1 million to New York State to fund the state library which covers 55 of the 84 positions at the state library. Defunding

the organization would leave few staff to administer the \$104.6 million in State Aid that funds critical infrastructure for your library such as:

- Operating aid to the Mid-Hudson Library System. This underwrites mission critical services for your library such as the software that runs front desk operations, the online catalog, and mobile app as well as physical delivery.
- **Central Library Service Program Aid.** This aid pays for important eResources such as the OverDrive platform that houses all of the ebooks and downloadable audiobooks your library purchases as well as the entire eMagazines package, Transparent Language, and JobNow.
- State Aid for Library Construction. Our region receives over \$1 million to invest public library facilities. DLD serves as the liaison between our system and the Dormitory Authority of New York State to champion our applications and comply with a multitude of state regulations.
- **NOVELny.** Essential research databases for schools and libraries, ensuring equitable access to information literacy skills for students of all ages.
- Legislative and Discretionary Grant administration. When your state legislator is able to earmark funds for your library for special projects DLD administers those funds to get them into your hands.

DLD also spearheads important projects that advance topics such as early literacy initiatives, digital equity, and documentary heritage and preservation services.



**Q:** What is the Institute of Museum and Library Services (IMLS) and how would its defunding impact my library?

A: IMLS is an independent federal agency founded in 1996 to administer the Library Services and Technology Act (LSTA) and the Museum Services Act. The agency uses congressionally mandated funding, such as the Grants to State program, as well as discretionary funding programs, such as the Laura Bush 21st Century Librarian Program, to meet the essential information, education, research, economic, cultural, and civic needs of the American public. IMLS is strategically focused on four areas of work:

- 1. Champion Lifelong Learning
- 2. Strengthen Community Engagement
- 3. Advance Collections Stewardship and Access
- 4. Demonstrate Excellence in Public Service

The Grants to States program is what funds the operations of the New York State Division of Library Development. See answer above for why that matters!

The library community also relies on IMLS grant-funded projects to advance the profession. In 2024 alone, IMLS awarded over \$260 million in grants, research and policy development, to advance, support and empower libraries. Over the years they have created key resources our community relies on such as:

#### **Q:** What is "E-Rate" and how does it impact my library?

**A:** E-Rate is a federal program administered by the Federal Communications Commission (FCC) that provides as much as \$4 billion annually in discounts for telecommunications, broadband internet access and internal network connections to provide phone and internet services to eligible libraries (and schools).

The program is funded through the Universal Service Fund (USF) which has its origins in the 1934 Communications Act which stated that all people in the United States "shall have access to rapid, efficient, nationwide communications service with adequate facilities are reasonable charges." Updated in 1996 through The Telecommunications Act, the program was expanded to benefit Americans through their local library.

The amount of discount each library can receive under the program ranges from 20 to 90 percent and is determined using a matrix designed by FCC, with libraries located in rural and low-income areas receiving the highest discounts from the fund. The USF compensates the schools' and libraries' vendors for the amount of the discount.

Laurie Shedrick, MHLS Assistant Director and Technology Operations Manager annually offers training and consultations to help member libraries apply for the E-Rate Discounts.

In the news is the Supreme Court case, <u>Consumers' Research v. Federal Communications</u>
<u>Commission</u>, testing the constitutionality of the E-Rate program. "E-rate has been a highly successful, bipartisan program that has benefited tens of millions of students around the country since its inception," said Joseph Wender, the executive director of the Schools, Health, and Libraries Broadband Coalition, a Washington-based group that is a party in the case helping defend the nearly 30-year-old program. "The impact of losing these funds would be profound and devastating across the country."
